- 1. Annexed hereto and made a part hereof is a Plan of Merger setting forth the terms of the merger of each of (i) Nations Healthcare of Central Florida and (ii) Nations Healthcare of North Florida, into Nations Healthcare of Florida, as approved by the Board of Directors of Parent on February 25, 1997 and the Board of Directors of each of Nations Healthcare of North Florida, Nations Healthcare of Central Florida and Nations Healthcare of Florida on June 4, 1997.
- 2. The aforesaid Plan of Merger was adopted in accordance with the provisions of the Florida Business Corporation Act on June 4, 1997.
- 3. Pursuant to Section 607.1104 of the Florida Business Corporation Act, approval of the shareholders of each of the above-mentioned corporations was not required for the merger.

The effective time and date of the merger herein provided for shall be on July 1, 1997.

PLAN OF MERGER

- 1. Nations Healthcare, Inc. ("Parent"), a Florida business corporation and the owner of all of the outstanding shares of (i) Nations Healthcare of Central Florida, Inc. ("Nations Healthcare of Central Florida"), a Florida business corporation, (ii) Nations Healthcare of Florida, Inc. ("Nations Healthcare of Florida"), a Florida business corporation and (iii) Nations Healthcare of North Florida, Inc. ("Nations Healthcare of North Florida"), a Florida business corporation, hereby merges (x) Nations Healthcare of Central Florida and (y) Nations Healthcare of North Florida into Nations Healthcare of Florida pursuant to the provisions of the Florida Business Corporation Act.
- 2. The separate existence of Nations Healthcare of Central Florida and Nations Healthcare of North Florida shall cease at the effective time and date of the merger, and Nations Healthcare of Florida shall continue its existence as the surviving corporation pursuant to the provisions of the Florida Business Corporation Act.
- 3. The issued shares of (i) Nations Healthcare of Central Florida and (ii) Nations Healthcare of North Florida shall not be converted in any manner, but each said share which is issued immediately prior to the effective time and date of the merger shall be surrendered and extinguished.
- 4. The shareholders of Nations Healthcare of Central Florida and Nations Healthcare of North Florida who, except for the applicability of Section 607.1103 of the Florida Business Corporation Act, would be entitled to vote and who dissent from the merger pursuant to Section 607.1320 of the Florida Business Corporation Act, may be entitled, if they comply with the provisions of the aforementioned section of the Florida Business Corporation Act, to be paid the fair value of their shares.
- 5. The Board of Directors and the proper officers of Parent and Nations Healthcare of Florida are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
