The taxpayer referenced above has requested that we contact your office regarding the enclosed notice of Administrative Dissolution for failing to file the 2001 Uniform Business Report (UBR). Mr. Howard Salus is a very conscientious businessman, who is certain he files every tax return he receives. Mr. Salus has no record of ever receiving the first UBR report or any of the follow-up notices sent out. During the first 6 months of 2001, Mr. Salus experienced an unusually large number of employee turnovers at his business.
