Dear Ms. Mortham:

The purpose of this letter is to request your office to waive the fee of \$400 relating to the filing of an Annual Report after May 1, 1998. My request is based on the circumstances noted below:

On June 26, 1998 I called the Division of Corporations to inquire regarding the 1998 Annual Report. My corporation has become relatively inactive (sales are under \$2,000 a year) and I wanted to know if that activity accounted for the fact that I hadn't seen the form usually received around this time. (I had just received correspondence from the Florida Department of Revenue changing my filing status.)

Your representative Linda kindly explained to me that so long as the corporation is alive an annual report must be filed. To determine why I hadn't received this year's form, she read my address. It read Miami. When that city is used in my address, there is a small, but very real probability that my mail will be lost. Some time ago I formally advised the post office, and although they acknowledge that I do reside in unincorporated Miami-Dade, they strongly suggested that the city of Hialeah be used instead, because this part of the county lies under the Hialeah post office's jurisdiction.

That same day Linda faxed me the details of my records and instructed me on how to order a blank report form. I received it just a couple of days ago and was astounded when I read the top line "FILE NOW: FILING FEE AFTER MAY 1<sup>ST</sup> IS \$550.

Please waive the \$400 fee in light of the fact that I had not received your form on a timely basis and therefore had received no warning regarding the extraordinary punishment for payment after May 1. Please review my records. You will see that I have always taken my reporting responsibilities seriously. I am attaching the form duly completed, a check for \$150, and a copy of Linda's fax, and await your determination.
