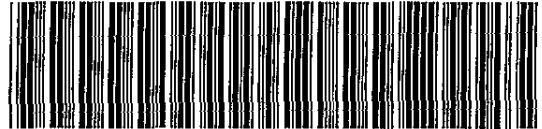

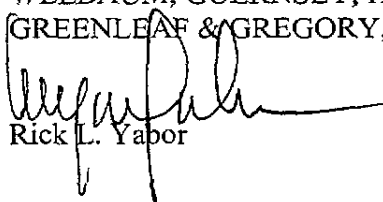

Amendment being adopted to Article I:

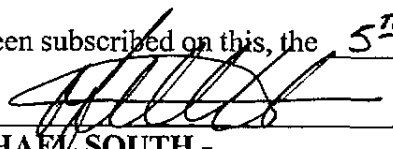

This amendment was approved by the corporate shareholders. The number of votes cast for the amendment was sufficient for approval.

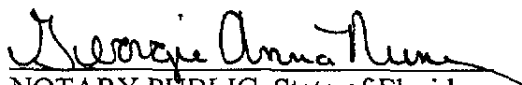
