AMENDMENT: The amount of Capital Stock shall be one hundred thirteen thousand dollars (\$113,000.00).

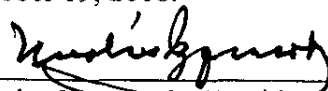

The amendment is made by resolution adopted by the Shareholders and Directors of Mixni Dynamic Trade, Inc. on October 19, 2006.

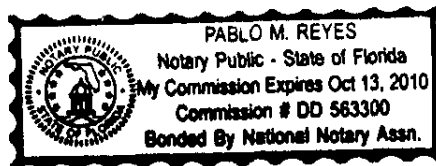
ARTICLE IV
