**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
METHOD PRODUCTS CORP.**

The Articles of Incorporation of the above-named corporation (the "Corporation"), filed with the Department of State on the 4th day of June, 1986 and assigned Document Number M33082, are hereby amended pursuant to a written consent in lieu of meeting executed and approved by the holders of all of the Corporation's common stock and all of the Corporation's Directors on the 27th day of July, 1998, as follows:

ITEM 1

1. ARTICLE III is hereby amended to read as follows:

ARTICLE III

The maximum number of shares of capital stock that the Corporation is authorized to issue is 50,000,000 shares, \$.0001 par value each share.

This Articles of Amendment to the Articles of Incorporation was adopted by the shareholders and Directors on the 27th day of July, 1998.
