AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER (this "Agreement") relates to the merger of each of East 26th Street Investments LLC, a Florida limited liability company (the "Non-surviving Entity 1"), Leon Support Services LLC, a Florida limited liability company (the "Non-surviving Entity 2"), Leon Kendall Holdings, LLC, a Florida limited liability company (the "Non-surviving Entity 3"), Hialeah West Investments, LLC, a Florida limited liability company (the "Non-surviving Entity 4"), and Leon Flagler Holdings, LLC, a Florida limited liability company (the "Non-surviving Entity 5" and together with Non-surviving Entity 1, Non-surviving Entity 2, Non-surviving Entity 3 and Non-surviving Entity 4, collectively, the "Non-surviving Entities" and each, a "Non-surviving Entity") with and into Leon Medical Centers, Inc., a Florida corporation (the "Surviving Entity").

- 5. Cancellation of Membership Interests and Assumption of Obligations. As of the Effective Date, by virtue of the Merger and without any action on the part of the Surviving Entity or the Non-surviving Entities, all outstanding membership interests of the Non-surviving Entities shall be cancelled and all outstanding shares of the Surviving Entity shall remain. Each shareholder of the Surviving Entity shall hold the same number of outstanding shares immediately prior to the Effective Date and immediately after the Merger. All outstanding dehi instruments and other obligations of each Non-surviving Entity, if any, shall convert to debt instruments and obligations, respectively, of the Surviving Entity.
