**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
CONTINENTAL PAPER PRODUCTS, INC.  
a Florida corporation**

Pursuant to the Florida Business Corporation Act, the Articles of Incorporation of **CONTINENTAL PAPER PRODUCTS, INC.**, a Florida corporation (the "Corporation"), are hereby amended as follows.

Article I shall be deleted in its entirety and replaced with the following:

**"ARTICLE I  
NAME**

*The name of this Corporation is James Baron/Pete Baron Inc."*

*In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this Amendment shall be effective upon its filing with the Florida Department of State.*

The foregoing amendment to the Articles of Incorporation of the Corporation were proposed by the board of directors of the Corporation and approved by the holders of a majority of the issued and outstanding shares of Common Stock of the Corporation, on March 11, 2004, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act. The number of votes cast for the amendment was sufficient for approval.


