

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FRED BONDESEN CHEVROLET, OLDSMOBILE, CADILLAC, INC.

- 1. The present name of the corporation is **FRED BONDESEN CHEVROLET**, **OLDSMOBILE**, **CADILLAC**, **INC**. Upon this amendment, the new name of the corporation shall be F R B AUTOMOTIVE, INC..
- 2. The Articles of Incorporation of FRED BONDESEN CHEVROLET, OLDSMO-BILE, CADILLAC, INC., heretofore approved and filed in the office of the Secretary of State, State of Florida, on October 13, 1986, are hereby amended in the following particular:
