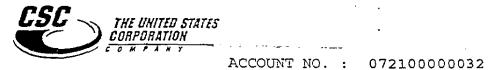

Pursuant to the relevant provisions of Chapter 607, Florida Statutes, the undersigned Florida corporation adopts the following articles of amendment to its articles of incorporation.
