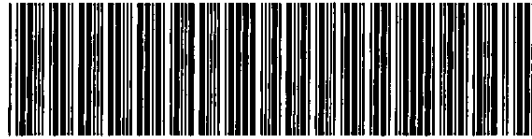


THIRD: The dissolution was authorized on January 22, 2007.
