**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
INTERNATIONAL TRADE ASSOCIATES, INC.**

The Articles of Incorporation of International Trade Associates, Inc., a Florida corporation (the "Corporation") have been amended by resolution of the Board of Directors of the Corporation dated 12/1, 2000 and approved by the sole shareholder on 12/1, 2000, as follows:

- A. The name of the corporation is International Trade Associates, Inc.
- B. Article III of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and restated as follows:

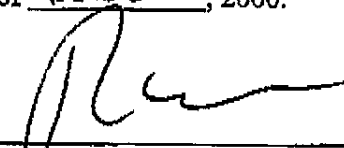
**III. STOCK**

**SECTION A:** The authorized common capital stock of this Corporation shall be divided into two (2) classes as follows:

1. Class A Voting Common. The Corporation is authorized to issue 500 shares of Class A Voting Common Stock having a par value of \$1.00 per share.
2. Class B Non-Voting Common. The Corporation is authorized to issue 100 shares of Class B Non-Voting Common Stock having a par value of \$1.00 per share.

Class A Voting Common Stock and Class B Non-Voting Common Stock shall confer identical rights to the holders thereof, except for the difference in voting rights. Holders of Class A Voting Common Stock shall have the right to vote on all matters which may properly come before the Shareholders of the Corporation. Class B Non-Voting Common Stock shall not confer any voting rights on the holders thereof.

IN WITNESS WHEREOF, the undersigned President of the Corporation has executed these Articles of Amendment on this 12 day of December, 2000.
