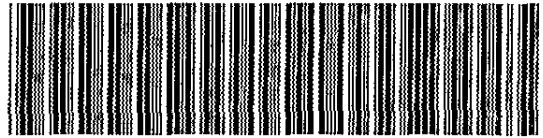

“The total unauthorized capital stock of this Corporation shall consist of 7,500 shares of Common Stock, par value \$1.00 per share.”

shall be amended to read as follows:


“The total authorized capital stock of this Corporation shall consist of 7,500 shares of Common Stock, par value \$.01 per share.”
