I am writing on behalf of my above referenced client. Taxpayer has advised me that they received correspondence that the corporation has been administratively dissolved. Taxpayer adamantly attests that they never received the Corporate renewal papers and unlike any other taxpayer they are not cognizant when these things are due without being advised or notified.

I realize that a second notice is usually sent, but they also did not receive this. I have known this taxpayer for years and know this taxpayer to be concerned and compliant. There would have been absolutely no reason for them not to complete and renew the annual report. The only explanation they can think of is that perhaps delivery if made was during a period when their usual mail carrier was on vacation or that indeed the forms were somehow lost.
