AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ADP TOTALSOURCE FL XV, INC.

Pursuant to Sections 607.1003, 607.1006 and 607.1007 of the Florida Rusiness Corporation Act, the Articles of Incorporation of ADP TOTALSOURCE FL XV PNCE originally filed with the Secretary of State of the State of Florida on April 22, 1987, are hereby amended and restated in their entirety as of the 10th day of August, 2005 as follows:

ARTICLE I NAME

The foregoing amendment and restatement was adopted on June 30, 2005 pursuant to the written consent of the Sole Director and the Sole Shareholder of the Corporation pursuant to the
