

**NOTICE OF CORPORATE DISSOLUTION

This Notice of Corporate Dissolution is being submitted by Daton Systems Corp., a Florida corporation (the "**Corporation**"), for resolution or payment of any and all unknown claims against the Corporation pursuant to Section 607.1407, Florida Statutes.

1. The name of the Corporation is Daton Systems Corp.
2. The effective date of the dissolution of the Corporation is the date the dissolution is filed with the Florida Department of State.
