ARTICLES OF INCORPORATION

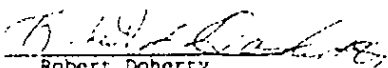
TO: SECRETARY OF STATE, STATE OF FLORIDA, TALLAHASSEE,
FLORIDA

1. The undersigned natural persons of the age of twenty-one or more, acting as incorporators of a corporation under title 607.164, of the LAWS of the State of Florida, adopt the following Articles of Incorporation for such corporation.

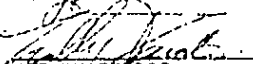
1. The name of the corporation, hereinafter referred to as the Corporation shall be DOHERTY & ASSOCIATES, INC.
2. The duration of the Corporation shall be perpetual.
3. The objects and purposes for which this Corporation is organized is to engage in the ownership and management of a security service business and any other business permitted by law.
4. The aggregate number of shares which the Corporation is initially authorized to issue is one thousand (1,000). There shall be one class of stock with a par value of one dollar (\$1.00). There shall be no preferences, qualifications, limitations, restrictions or special rights with respect to the one class of stock.
5. Shareholders have the pre-emptive right to acquire additional shares of stock.
6. Provisions for the regulation of the internal affairs of the Corporation are contained in the By-Laws of the Corporation.

7. The Corporation will not commence business until at least one thousand dollars (\$1000.00) has been received by it as consideration for the issuance of shares.
8. The initial registered office and principal place of the corporation shall be located at 21940 Griffin Road, Fort Lauderdale, Florida 33332. The initial registered agent at said premises shall be Robert Doherty.
9. The following person shall constitute the initial Board of Directors of the Corporation, and shall serve until the first annual meeting or until their successors shall be elected: Robert Doherty, who resides at 21940 Griffin Road, Fort Lauderdale, Florida 33332.
10. The incorporator of this Corporation is Robert Doherty who reside at the address stated in paragraph (9).
11. The Articles of Incorporation shall constitute a binding agreement and may be amended by the affirmative vote of majority of the Board of Directors in Office.
