Article IV of the Articles of Incorporation of MARINE HOSPITALITY CORPORATION, a Florida Corporation, hereinafter referred to as the "Corporation", is hereby amended to read as follows:

 - 200,000,000 shares shall be designated Preferred Stock, and shall have a par value (ii) of \$.0001 per share.
