Our firm Alvarez & Fernandez PA, CPA's have been engaged as a new accountants for Sabor Feed, Inc. Sabor's previous accountant for many years, Mr. Emilio Varela, C.P.A., got sick thru the end of the first quarter of 1999, and was hospitalized several times thru the year. It has been explained to us by his widow, who worked with him in his practice, that when he was not hospitalized, he tried to catch up in running his practice, until he finally died on October 4, 1999.

After his death, her widow tried to maintain as much level of service as possible, in the circumstances, of their small practice. However, as have been explained to us by several of his clients, whom has been referred to us thru the past three months by Mr. Varela' widow, his firm's work got behind during his sickness and after his death in numerous aspects, including the one affecting Sabor Feed, Inc. with the Department of State.
