**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
LENNAR CAPITAL SERVICES, INC.**

The undersigned, Steven N. Bjerke, being a duly elected Vice President of LENNAR CAPITAL SERVICES, INC., a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:

1. The Articles of Incorporation of the Corporation (as amended, the "Articles") were filed with the Secretary of State of the State of Florida on June 6, 1988, under Document Number M56607 and under the original charter of "Loan Funding, Inc." Articles of Amendment thereto were filed with the Secretary of State of the State of Florida on July 3, 1995, whereby the name of the Corporation was changed to Lennar Capital Corporation.

2. Pursuant to the requirements of Sections 607.1006 and 607.1007 of the Florida Business Corporation Act, the undersigned hereby certifies, attests and serves notice that the Articles of the Corporation are hereby amended and restated in their entirety to read as follows, which Amended and Restated Articles of Incorporation incorporate amendments to all articles of the Articles of the Corporation:

ARTICLE I - NAME

The name of this corporation is LNR CAPITAL SERVICES, INC.

ARTICLE VIII -- INDEMNIFICATION


This corporation shall indemnify any officer, director or incorporator, or any former officer, director or incorporator, of this corporation to the fullest extent permitted by law.


ARTICLE IX – AMENDMENT
