
Dear Mr. Siberio:

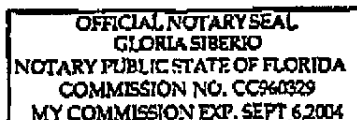


