CHILDREN'S ANESTHESIA ASSOCIATES, P.A.

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Second Amended and Restated Articles of Incorporation:

- 1. The name of the corporation is Children's Anesthesia Associates, Inc. (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was November 30, 1987 and the Articles of Incorporation were amended on June 29, 2018.
- 2. The Second Amended and Restated Articles of Incorporation were unanimously adopted and approved by the sole director and sole shareholder of the Corporation on June 30, 2018.

The Articles of Incorporation are hereby further amended and restated in their entirety as follows:

#### **ARTICLE I - NAME**

The name of this corporation is Children's Anesthesia Associates, Inc. (the "Corporation").

#### ARTICLE II - TERM

The corporate existence of the Corporation shall be perpetual, unless and until terminated pursuant to Florida law.

#### <u>ARTICLE III - PURPOSE</u>

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.

#### **ARTICLE IV - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of this Corporation, unless and until relocated, is 7700 West Sunrise Boulevard, Plantation, Florida 33322.

#### ARTICLE V - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is Seven Thousand Five Hundred (7,500) shares of Common Stock, par value \$1.00 per share.
