## Articles of Amendment To The Articles of Incorporation

of

## CATLIN, SAXON, TUTTLE AND EVANS, P.A.



At a special meeting of the Shareholders and the Board of Directors of Catlin, Saxon, Tuttle and Evans, P.A. held on April 26, 2000, at which a quorum was present and at which Shareholders holding one hundred percent (100%) of the shares of stock of Catlin, Saxon, Tuttle and Evans, P.A. were present either in person or by proxy, the Shareholders and Directors, by unanimous vote, approved the following amendments to the Articles of Incorporation, with such amendments to be effective as of April 26, 2000:

- 1. The name of the corporation in the heading of the Articles of Incorporation is changed from "CATLIN, SAXON, TUTTLE AND EVANS, P.A.", to "CATLIN SAXON TUTTLE EVANS FINK & KOLSKI, P.A."
- 2. Article I is amended to read as follows:

## ARTICLE I - NAME

The name of the corporation shall be CATLIN SAXON TUTTLE EVANS FINK & KOLSKI, P.A.
