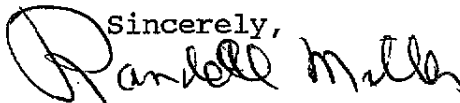

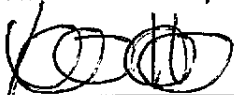
Article I shall be deleted in its entirety and the following

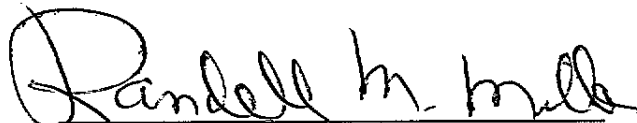
