**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
Intermart Broadcasting Gulf Coast, Inc.**

Intermart Broadcasting Gulf Coast, Inc., pursuant to Section 607.1006, Florida Statutes, does hereby file the following Articles of Amendment:

1. That the name of the Corporation is Intermart Broadcasting Gulf Coast, Inc.
2. That Article III of the Articles of Incorporation of Intermart Broadcasting Gulf Coast, Inc. is hereby amended to read as follows:

**ARTICLE III. CAPITAL STOCK**

The authorized capital stock of this corporation shall be 2,000 shares of common stock, which shall consist of 1,000 shares having voting rights and 1,000 shares without voting rights, except as otherwise provided by applicable law. All shares shall have a par value of \$1.00.

3. That the foregoing amendment was adopted by the Board of Directors on September 8, 1997 and no action by shareholders is required.
