## ARTICLES OF AMENDMENT TO

### ARTICLES OF INCORPORATION

OF

#### NEWGEN INVESTMENT CORPORATION

- 1. The Articles of Incorporation of Newgen Investment Corporation. Document Number M68043, were filed on February 8, 1988, no further amendment has been made to that document.
