**FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
THE ARTIFICIAL KIDNEY CENTER OF BROWARD, INC., A FLORIDA  
CORPORATION**

Pursuant to Section 607.1006, Florida Statutes, the undersigned officer, being duly authorized, empowered and directed to act, hereby files this First Amendment (hereafter, the "First Amendment") to the Articles of Incorporation of The Artificial Kidney Center of Broward, Inc. (hereafter, the "Corporation"), and hereby certifies as follows:

1. The original Articles of Incorporation of the Corporation were filed with the Department of State for the State of Florida on February 16, 1988 under document number M68934.
2. This First Amendment was adopted by unanimous vote of the shareholders and the directors of the Corporation on June 9, 1998, such unanimous votes being sufficient for approval of the First Amendment. The amendment included herein has been adopted pursuant to applicable sections of the Florida Statutes and is effective on the date that this First Amendment is filed with the Department of State of the State of Florida.
3. Article I of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:  
Article I  
Name  
The name of this Corporation shall be: Cosaro, Inc.
4. Except as amended by this First Amendment, the Articles of Incorporation of the Corporation are hereby adopted and restated as set forth in the original Articles of Incorporation of the Corporation.
