I represent the above named taxpayer and the company recently received the attached Corporation Annual Report- second notice. We are requesting waiver of the \$400 penalty for late filing because we believe there are mitigating circumstances justifying such a request.

The taxpayer sold substantially all of the assets of the business in the Fall of 1998. The owner intends to continue the corporation until the "loose ends" of the sale are finalized. As part of the sale of assets, the buyer assumed the operations of the taxpayer's manufacturing facility located at 7555 Garden Road, Riviera Beach, FL. It appears that the first notice was mailed to that location and the present occupant (the buyer) failed to forward the paperwork to my client. They did, however, forward the attached second notice which my client received upon his return to Florida this week. Since in prior years the company's accounting staff would handle the filing of the report, my client was unaware that he should have received the corporate filing paperwork.

This company is now a one-person business and payment of the total requested would result in a serious financial burden. I know that the penalties and fees are established by the Florida legislature, but I am also aware of similar unintentional oversights in which late penalty waivers have been granted.
