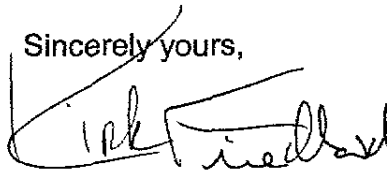

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
CULINARY DESIGNS, INC. CHANGING NAME TO
