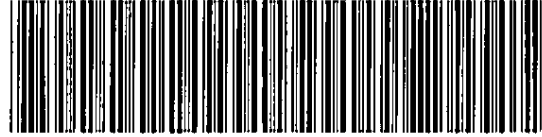

Article III of the articles of incorporation of **GROSS & SON PAINT & BODY SHOP, INC.** was amended by the corporation's board of directors and by its sole shareholder on June 6, 2023. The corporation is filing these articles of amendment to articles of incorporation pursuant to Florida Statutes Section 607.1006.


1. The name of the corporation is **GROSS & SON PAINT & BODY SHOP, INC.**
2. Article III of the articles of incorporation of **GROSS & SON PAINT & BODY SHOP, INC.** was amended as follows:

ARTICLE III - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock divided into six thousand (6,000) shares of voting common stock with a par value of One Dollar (\$1.00) per share and four thousand (4,000) shares of non-voting common stock with a par value of One Dollar (\$1.00) per share. The holders of the Voting Common Stock shall be entitled to vote to elect members of the corporation's board of directors. In all other respects the Voting Common Stock and the NonVoting Common Stock shall be identical.

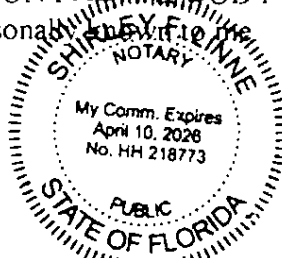
3. The foregoing amendment to articles of incorporation was duly adopted by the board of directors on June 6, 2023 and was approved by the corporation's sole shareholder at a Shareholder's meeting on June 6, 2023.


