With reference to my recent conversation with your office, I Have enclosed the corporate reinstatement document as well as the required funds as discussed.


In May 1998, I, as a foreign person and a non US resident, purchased the company Peter Pan Child Care Center Inc.. The closing attorney was to have forwarded the relevant resignation and appointment of the new corporate officers. It appears as if these documents were never forwarded to the Division of Corporations, along with the correct mailing address of the registered agent. The agent for this corporation received no annual reports.

Being a foreigner and unaware of how the corporate registration structure functions, I was not aware that this corporation was inactive and it was only recently that our CPA brought the status of the corporation to my attention.

I have enclosed the required \$750.00 reinstatement fee, as stated by your office, \$150.00 for each annual report not filed. I therefore request that any additional fees and charges be waved and the corporation reinstated with immediate effect.

I have also included the documentation and relevant filing fees for a change of directors of the corporation (\$35.00) to be reinstated as well as a merger of this corporation (\$35.00)
