The date dissolution was authorized is November 16, 2000.

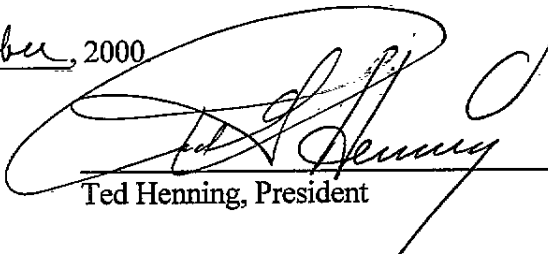
THIRD
