FOURTH AMENDMENT TO THE ARTICLES OF INCORPORATION OF NEW AGE PAINTING, INC.

Pursuant to Section 607.1006 of the Business Corporation Act of the State of Florida, the undersigned President of New Age Painting, Inc., a corporation organized and existing under and by virtue of the Business Corporation Act of the State of Florida, does hereby certify that pursuant to Written Consent of the Board of Directors and Majority Shareholders of the Corporation dated May 22, 2002, the Shareholders and Directors approved the following fourth amendment to the Corporation's Articles of Incorporation bearing document number M99195, and does hereby certify:

ARTICLE IV of the Articles of Incorporation of this corporation shall be amended to read as follows:

"ARTICLE IV AUTHORIZED SHARES

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is ONE BILLION (1,000,000,000) SHARES of Common Stock, all of one class, having a par value of \$0.0001 per share."

The foregoing amendment was adopted by all of the majority shareholders and Directors of the Corporation by Written Consent dated May 22, 2002, acting unanimously by Written Consent pursuant to Section 607.0704 of the Florida Business Corporation Act. Therefore, the number of votes cast for the amendment to the Corporation's Articles of Incorporation was sufficient for approval.
