## FIFTH AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to Section 607.1006 of the Business Corporation Act of The State of Florida, the undersigned Chairman of New Age Painting, Ind., a corporation organized and existing under and by virtue of the Business Corporation Act of the State of Florida, does hereby certify that pursuant to meetings of the Board of Directors and Majority Shareholders of the Corporation held June 3, 2002, the Shareholders and Directors approved the following fifth amendment to the Corporation's Articles of Incorporation bearing document number M99195, and does hereby certify:

ARTICLE I of the Articles of Incorporation of this corporation shall be amended to read as follows:

## "ARTICLE I NAME OF THE CORPORATION

The name of this Corporation is Winner International, Inc.

The foregoing amendment was adopted by all of the majority shareholders and Directors of the Corporation by meetings held June 3, 2002, pursuant to the Florida Business Corporation Act.
