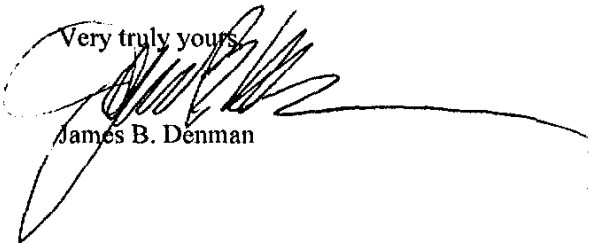
The undersigned represents Greenturf, Inc.
