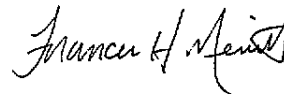

LAW OFFICES OF EDWARD C. BESHARA, P.A., a Florida professional association (the "P.A."), by and through its President, hereby adopts an amendment to its Articles of Incorporation as hereinafter set forth.

1. Pursuant to Section 607.1003 of the Florida Statutes, the Board of Directors of the P.A. and the shareholders of the P.A. adopted, in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, on July 25th, 2001, an amendment to Article I of the Articles of Incorporation of the P.A., deleting Article I in its entirety and substituting therefor the following:

ARTICLE I - Name

The name of this Professional Association shall be:

AVIEWTRANS IMMIGRATION RELOCATION FIRM, P.A.

2. Except as modified hereby, the Articles of Incorporation of the P.A. shall be and remain in full force and effect.

3. The number of votes cast for the amendment by the shareholders was sufficient for approval, and the P.A.'s shareholders are not divided into different voting groups.
