This law firm has the privilege of representing K.C. Window Cleaning Service, Inc. both as it's legal counsel and registered agent. We recently received notification from your office that this corporation has been administratively dissolved for failure to file it's 2000 Corporation Annual Report/Uniform Business Report. Our application for reinstatement is enclosed together with our check in the amount of \$150.00 with the following request to waive any penalties or additional fees.

The Notice of Administrative Dissolution was the first notification we had received this entire year regarding this corporation. Upon closer scrutiny it appears that the suite number was incorrectly listed on the Notice as suite 210, when it had changed last year to suite 100.
