

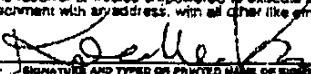

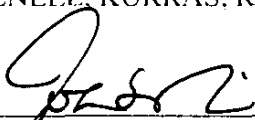
I am returning the original report filed and your letter and ask that you accept this report as being filed.
