FIRST AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

AZUVI, INC.

Azuvi, Inc., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), does hereby certify pursuant to Section 607.1007 of the Florida Statutes, that:

- 1. The name of the Corporation is Azuvi, Inc.
- 2. The First Amended and Restated Articles of Incorporation of the Corporation restate and amend the Articles of Incorporation of the Corporation, as amended from time to time. The First Amended and Restated Articles of Incorporation were adopted by the Directors and Shareholders of the Corporation by unanimous consent action dated 2/44/, 2004 pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.
- 3. The text of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety as follows:

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on June 29, 1988, unless dissolved according to law.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE X - AMENDMENT OR REPEAL

The Corporation reserves the right to amend, alter, or repeal any other provision contained in these First Amended and Restated Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights of Stockholders herein are subject to this reservation.
