The undersigned do hereby certify as follows:

1. The name of this corporation is PGA TOUR Strategies, Inc.
2. An amendment to Article I of the Articles of Incorporation has been adopted by the sole shareholder of this Corporation pursuant to Sections 607.0704 and 607.1003, Florida Business Corporation Act, to change the name of the Corporation to PGA TOUR GCP International, Inc. As amended, Article I now reads:

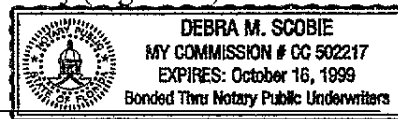
