**ARTICLES OF AMENDMENT TO THE

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), Atlantic Precision, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ATLANTIC PRECISION, INC.
2. The Corporation's Articles of Incorporation were filed with the Florida Secretary of State on June 27, 1988 and assigned Florida document number M88571.
3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced in its entirety with the following new Article I:


**ARTICLE I – CORPORATE NAME**
