**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF POMERLEAU GROUP USA, INC.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, Pomerleau Group USA, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

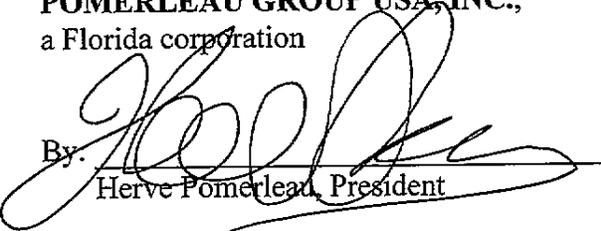
1. The name of the corporation is Pomerleau Group USA, Inc.
2. The original Articles of Incorporation for the corporation were filed on July 11, 1988, and assigned Charter No. M88979.
3. By a written consent executed on December 21, 2000 by the sole director and sole shareholder of the Corporation, respectively, the sole director and sole shareholder have approved an amendment to the Corporation's Articles of Incorporation increasing the number of shares of its authorized no par value common stock from one hundred (100) shares to one hundred thousand (100,000) shares. The amendment was approved by the sole director and sole shareholder of the Corporation and the number of votes cast for approval was sufficient.
4. Article Four of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE FOUR

The Corporation is authorized to issue one hundred thousand (100,000) shares of common stock. Such shares shall be of a single class, and shall be without par value.

IN WITNESS WHEREOF, the undersigned officer of the corporation has executed these Articles of Amendment to Articles of Incorporation on behalf of the Corporation this 21st day of December, 2000.
