ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF HEARTWOOD-PROMENADE INCORPORATED

Pursuant to the provisions of Section 601.1006 of the Florida Business Corporation Act,

HEARTWOOD-PROMENADE INCORPORATED, a Florida corporation (the "Corporation"),

adopts the following articles of amendment to its Articles of Incorporation.

ARTICLE I

The name of the Corporation is Heartwood-Promenade Incorporated.

ARTICLE II

Article I of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

The name of the Corporation is Heartwood Holdings, Inc.
