ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SUNSET OAKS DENTAL GROUP, P.A.

Pursuant to the provisions of Sections 607.1006, Florida Statutes, SUNSET OAKS DENTAL GROUP, P.A., a Florida corporation (incorporated on August 4, 1988, under the name of Martha E de la Iglesia, D.M.D. and Reinol A. Gonzales, D.M.D., P.A., Document Number M92649, and hereinafter referred to as the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

I. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted therefor:

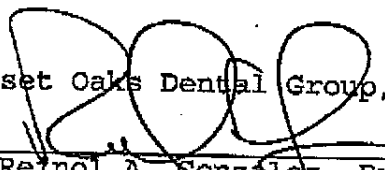
ARTICLE I
