The end of 1998, I was called to New Orleans for a kidney transplant operation. I spent many months in New Orleans and though the transplant was not a success, I was kept in the hospital as I had fluid on the lungs and congestive heart failure.

Each weekend, my husband brought me all the mail which I kept in a file or put in its proper place. I would have put the report in with my March-April-May tax and report forms. I do not ever remember receiving the form. I checked with my tax preparer to see if it got in his file but it did not. No one recalls seeing it at any time.
