ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CENTRAL FLORIDA CYCLE & SKI, INC.



WHEREAS, the name of the Corporation is Central Florida Cycle & Ski, Inc.; and LORIDA

WHEREAS, the Corporation was incorporated pursuant to the provisions of the Florida General Corporation Act, on August 17, 1988; and

WHEREAS, the undersigned Corporation, by and through its Directors and pursuant to the provisions of Section 607.1001 of the Florida Statutes, wish to amend the aforesaid Articles of Incorporation; and

WHEREAS, the Board of Directors and Shareholders at a meeting held as of January 10, 1997, unanimously agreed to amend the aforesaid Articles of Incorporation in the manner hereinafter set forth:

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article III - Capital Stock of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE III - CAPITAL STOCK

The authorized capital stock of this Corporation and the maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 75,000 shares of common stock having a par value of \$0.01 per share."

2. Except as modified herein, the Articles of Incorporation of said Corporation shall be and remain in full force and effect.
