Business Corporation Act on the 1st day of August, 2001.


NOW, THEREFORE, the Articles of Incorporation of the Corporation are hereby amended

1. Article I is deleted in its entirety and the following is substituted therefor:


The name of this Corporation shall be "KGS OF CENTRAL FLORIDA, INC.".
