AFFIDAVIT

I, Toby Grauman, President of Equity Partners, a commercial investment firm, am manager of Raintree Properties, LLC and represent Elizabeth Rand, manager of Silver Spring Properties, LLC and Alhambra Circle Properties, LLC all with offices at 1300 Arcola Avenue, Wheaton, Maryland 20902.

In my position, I handle correspondence for all the above-referenced companies. I receive all mail and respond to letters, bills, payments etc. from all sources.

Over the past year, I have experienced numerous instances where mail addressed to all of the above-referenced companies, as well as other business mail was wrongly delivered to another address. In a number of those situations, the mail was not re-delivered to my office for quite some time until the wrongly delivered mail was returned to the post office by the other party and then delivered to my office. In other instances, the mail was never re-delivered.

With regard to the 1998 Limited Liability Company Annual Reports for Silver Spring Properties, LLC, Alhambra Circle Properties, LLC and Raintree Properties, LLC, I can state that I did not receive those notices in a timely fashion prior to May 1, 1998. Had I received the notices in a timely fashion, I would have paid the appropriate fees as I have done in the past. The above-referenced Limited Liability Company Annual Reports were all delivered to the wrong address and never forwarded to my office. In fact, I just recently received letters dated October 21, 1998 addressed to all three limited liability companies informing them that earlier 60 day notices dated June 26, 1998 had not been responded to thereby administratively revoking the respective certificates of authority effective October 16, 1998. Needless to say, I never received those notices dated June 26, 1998 either.

Attached to this AFFIDAVIT please find a letter from the Postal Service, Wheaton Branch, that handles all mail delivered to my office, in support of my position.


