Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation, for the purpose of changing from a professional corporation under Chapter 621, Florida Statutes, to a business corporation under Chapter 607, Florida Statutes.

FIRST: The following Amendments have been adopted by the corporation:

ARTICLE I

The name of the corporation shall be:

ARTICLE II

NATURE OF BUSINESS

The general nature of the business is the purpose of engaging in and transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, and the laws of the United States of America.
