**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, Fred H. Pryor, Jr., President of HUNTON, BRADY, PRYOR & MASO ARCHITECTS, P.A., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

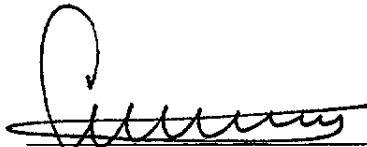
ARTICLE I - NAME
